I understand that participation in the Activities is strictly voluntary and I freely chose to have my child(ren) participate. I acknowledge that there may be risks to my child(ren) by taking part in the Activities. I verify that I will be responsible for any medical costs that may incur as a result of my child(ren)’s participation.

I consent to the photographing, recording and reproduction of the likeness, voice and participation activities of the child(ren) listed above, including but not limited to slides, movies, video, or other media coverage or social networking, taken in connection with the children’s involvement in the Activities, without monetary or other compensation from the City or its departments, employees, or elected officials and used for any legal purpose.

I understand this Waiver and Release is intended to be as broad and inclusive as is permitted by the law of the State of Colorado, and that if any portion hereof is held invalid, it is agreed that the remaining terms of this Waiver and Release shall continue in full legal force and effect. I acknowledge that any dispute will be decided according to the laws of the State of Colorado.

Nothing in this Waiver and Release shall be construed to waive, limit, or otherwise modify any government immunity that may be available to the City and its officers, officials, appointees, employees, agents and representatives under the Colorado Governmental Immunity Act, Colorado Revised Statutes §24-10-101 et seq.
