

DENVER INTERNATIONAL AIRPORT (“DEN”) Beer Passport GIVEAWAY (“Sweepstakes”)

(OFFICIAL RULES)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

1. BINDING AGREEMENT: In order to enter and be eligible for the Sweepstakes, you (“Participant” or “Participants”) must agree to these Official Rules (“Rules”). These Rules form a legally binding agreement with Participants with respect to the Sweepstakes, so please read them carefully. Participant agrees that registration for the Sweepstakes or a submission of an entry in the Sweepstakes constitutes an agreement to these Rules.

2. ELIGIBILITY: To enter, Participants must be at least 21 years of age. Participants must share a photo of themselves with the DEN Beer Passport on Facebook or Twitter in order to be eligible for the prize. The Sweepstakes is void where prohibited. Employees (including without limitation, part-time, temporary, and volunteer employees) of the City and County of Denver (“City”), Westin Denver International Airport (collectively, “Prize Providers”), and affiliated companies, and immediate family members of such employees, are not eligible to participate in the Sweepstakes.

HOW TO ENTER; SWEEPSTAKES PERIOD; WINNER NOTIFICATION: Instructions on how to participate in the Sweepstakes and submit an entry will be posted on the Sweepstakes Website, www.facebook.com/denverinternationalairport, and twitter.com/DENAirport. Only Participants meeting the eligibility standards and instructions may submit entries to the Sweepstakes. Entries sent by means other than as described at www.facebook.com/denverinternationalairport are not eligible for the Sweepstakes. The Sweepstakes begins at 10:00 a.m. Mountain Standard Time (MST) on Feb. 4, 2020 and closes at 11:59 p.m. MST on April 1, 2020 (“Sweepstakes Period”). Only one entry per Participant will be accepted. Email entries are prohibited. City will randomly select a winner from all eligible entries received during the Sweepstakes Period and will notify the winner via social media by April 3, 2020. City accepts no responsibility for submissions that are lost, delayed, damaged, not received, or that do not comply with these Rules or the submission requirements. All submissions to the Contest will become the property of the City.

4. CONSUMER DISCLOSURE: PRIZES: One (1) prize includes:

PRIVACY NOTICE: By participating in the Sweepstakes, Participant agrees that City may collect and use your personal information, and that if any required data or information cannot be collected, Participant may not be eligible to participate in the Sweepstakes. Participants acknowledge that City is subject to the provisions of the Colorado Open Records Act, Colorado Revised Statutes sections 24-72-201 *et seq.*, and Participants agree that they will fully cooperate with City in the event of a records request or a lawsuit for the disclosure of any materials or information which any Participant asserts is confidential and exempt from disclosure. Notwithstanding any other provision of these Rules, all materials, records, and information provided by Participants to City will be considered confidential by City only to the extent provided in the Colorado Open Records Act, and Participants agree that any disclosure of information by City consistent with the provisions of the Open Records Act shall result in no liability of City.

8. MEDIA ACTIVITY: Except where specifically prohibited, by participating in the Sweepstakes, Participants agree and hereby grant City irrevocable rights and permission to use, copy, modify, and make available any and all Sweepstakes submissions to the public for any purpose and in any form, including, but not limited to, press and media communications, without any compensation to Participants. Participants also agree to participate in any media or promotional activities regarding the Sweepstakes. Any Participant that wins a prize in the Sweepstakes agrees that City may use names, likenesses, and other information submitted to City to administer and promote the Sweepstakes, DEN, or airport services, and to conduct media interviews and promotional events.

City reserves the right to update these Rules, and it is the responsibility of each Participant to be aware of any updates.
